Crowborough’s Christmas Cracker is scheduled to take place on Friday 29th November. Booking is now open for pitches, the cost of which is £20.00 per pitch.

For those wishing to participate, subject to weather conditions, we will be able to offer undercover stalls with 6ft table which will be situated in the High Street. Although stalls will be supplied with overhead lighting, it is advisable to bring another form of lighting for your stall by way of light strings or other battery driven lamps, as well as chairs if required.

Please note, you cannot enter the stall from the rear and the trestle tables are part of the structure. To be able to get behind the trestle table you will need to be able to bend under it which may be problematic for some. **Please consider this before you proceed with the booking. Alternatively, you may decide to remove the table in front and place your own table, inside the marquee, against the back wall. This would allow you to get access in and out of the marquee without bending down.**

Pitches will be available to businesses at a cost of £20.00 per pitch and, as we have a limited amount available to us, they will be allocated on a “first come, first served basis”. **Please note pitch fees are nonrefundable.**
